Call to Order: Chairman called the meeting to order at 1417

Secretary's Reports: Motion to accept February's report was made by Chris Witteveld, seconded by Linda Jette and approved. The March 15th trustee's meeting had been cancelled by Jim Cobb and Diane Heer due to a major snow storm on Tuesday, March 14th and it's potential impact on travel and cleanup on the 15th.

Treasure's Reports: Motion to accept February's report, was made by Jim Cobb, seconded by Linda Jette and approved. Motion to accept March report, was made by Chris Witteveld, seconded by Linda Jette and approved.

Director's Report: Circulation is up as well as programs offered. Upcoming events occurring in May were discussed with emphasis on the Timberlane High School documentary "Soldiers Home and Away" which is getting rave reviews. Hampstead Public Library (HPL)has expressed an interest in the Southern NH Library Cooperative. SNHLC's members are Atkinson, Plaistow and Sandown.
